- 2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval ( ) to the left of the line provided, and write or print the name in the blank space provided for that purpose.
- 3. Use only black ink pen.
- 4. If you make a mistake DO NOT ERASE. Ask for a new ballot.
- 5. For Absentee Ballot Voters: "The official 5. For Mail-in Ballot Voters: "The official mail-in **6.** For Mail-in Ballot Voters: "The official mail-in voter ballot shall state that a voter who receives a mail-in ballot under section 1301-D and whose voted mail-in ballot is not timely received may only vote on Election Day by provisional ballot unless the elector brings the elector's mail-in ballot to the elector's polling place, remits the ballot and the envelope containing the declaration of the elector to the Judge of Elections to be spoiled and signs a statement subject to the penalties of 18 PA.C.S. § 4904 (relating to the unsworn falsification to the authorities) to the same effect."
