INSTRUCTIONS TO VOTER

1. TO VOTE YOU MUST COMPLETELY DARKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE. An oval (●) darkened to the left of the name of any candidate indicates a vote for that candidate.

2. To cast a write-in vote for a person whose name is not on the ballot, you must darken the oval (●) to the left of the line provided, and write or print the name in the blank space provided for that purpose.

3. Use only black or blue ink pen.

4. If you make a mistake DO NOT ERASE. Ask for a new ballot.

5. **WARNING:** If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on Election Day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on Election Day, unless you surrender your absentee or mail-in ballot and declaration envelope to the Judge of Election to be voided to vote by regular ballot.

Every elected office is important! Vote for the marked candidate for each office on both sides. Voted Mail-in Ballots must be received by November 4, 2025 at 8 pm. Postmarks do not count.
